**USER CLASSIFICATIONS**

**User classifications are consistent with the facility user classifications applied** throughout the San Leandro Unified School District (SLUSD), the following categories will be used in determining the rental fees associated with the San Leandro Arts Education Center (AEC).

**Direct Cost – Group A** School activities generated by SLUSD personnel or volunteers for purposes directly related to the education and enrichment of SLUSD students, as directed or approved by SLUSD administration, and/or for the purpose of employee gatherings related to the operation of the District will be charged discounted estimated direct costs associated with their event period. Direct cost is defined as an estimate of those costs of supplies, utilities, custodial services, building maintenance, services of any other District employees, and salaries paid to District employees as a result of the organization’s use of the AEC. Users of this category include:

- SLUSD Schools
- PTA/PTSA or other school-associated parent/teacher/student associations
- Student Body Clubs
- School employees in the performance of their duties.

**Direct Cost – Group B (Non Profit/Public Agency)\*** Non-profits, community based organizations and public agencies will be charged the estimated direct costs associated with their event period. Users in this classification include:

- Foundations whose purpose, through the use of the AEC, is to improve the general welfare of the youth or public school activities of the district.
- Non-profit (501c3) organizations that use the AEC for fundraising activities that are beneficial to the youth or public school activities of the district. Organizers, board members, activity supervisors, and other 501c3 officers may not draw salary from participation fees from said event.

**Direct Cost – Group C (Non Profit/Public Agency)\*** Non-profits, community based organizations and public agencies will be charged the estimated direct costs associated with their event period. Users in this classification include:

- Civic and service groups (e.g. Girl Scouts, Boy Scouts, Camp Fire, School Advisory
- Councils, Rotary, Foundations, Chamber of Commerce, League of Women Voters, booster clubs, local government agencies, and/or county services) whose purpose, through the use of the AEC, is to improve the general welfare of the youth or public school activities of the district.
- Conduct of religious services for temporary periods, on a one-time or renewable basis, by any church or religious organization that has no suitable meeting place for the conduct of services while meeting.
- Non-profit (501c3) organizations that use the AEC for fundraising activities which are beneficial to the youth or public school activities of the district. Organizers, board members, activity supervisors, and other 501c3 officers may not draw salary from participation fees from said event.

**Commercial (Fair Market) – Group D** Commercial represents a rate for commercial activity, regardless of where profit is generated within the organization.

- Rentals where admission or participation fees are charged, or contributions are solicited and the receipts are not expected for the welfare of the pupils of the District for charitable purposes.
- Rentals which are not directly beneficial to youth, public school activities of the District, or general welfare of the community.
- This fee structure may apply to “non-profit” organizations where organizers, activity supervisors, coaches, etc. draw salary from the activity or organization, and participation fees are received from students or adults.

\*Documentation of valid 501(c)(3) status and W-9 are required to verify non-profit status
